#### Introduction

The tables that follow represent the second update of the tables that appear in the 1999 Community Profile. This appendix will continue to be updated on an annual basis until the next full community profile is released in the next year or two. Included in this update is an index to the measures used, listing where each measure appears (1) in the full text of the 1999 Community Profile, (2) in the 1999 profile's appendix, (3) in the separate geographic tables document (where geographic-specific data are available), (4) in the 2000 update, and (5) in this 2001 update. Also included is a summary Population Profile, including available 2000 Census data for Monroe County.

In this 2001 update of the basic Community Profile data tables, in most cases, at least one year of data has been added to the tables. In some cases two years of data have been added, while in a few cases no updated information was available at the time of the update. Updated information for those few measures will be included in the next data update. The data in this document were collected at the same level of geographic specificity as appeared in the 1999 Profile. For example, data that were available only at the county level for that profile were still available only at that level for this update.

Table 116: Senior Self-Reported Ability to Perform Activities of Daily Living (ADLs)


