Wisconsin will have a smoke-free law.

More than half the country's population is covered by laws that make all restaurants and bars smoke-free, including most of our neighbors: Minnesota, Iowa and Illinois.

Many communities in Wisconsin have passed smokefree ordinances. A patchwork of local ordinances pits one community's laws against another's. This will continue to happen until Wisconsin passes a statewide law. We need a statewide smoke-free law passed quickly to ensure fairness for all businesses and communities. Going smoke-free is important for our health.

Secondhand smoke contains more than 4,000 chemicals, including 69 that cause cancer. It is a proven cause of heart disease, cancer, asthma attacks and other health problems.

A statewide smoke-free law is the only way to protect business owners, employees and customers from the proven dangers of secondhand smoke.

A strong smoke-free law can financially benefit your business.

Ventilation systems are very expensive and do not provide health protection from secondhand smoke. Lower maintenance and insurance costs, healthier workers who miss fewer shifts, and a larger customer base are just some of the potential business benefits of a smoke-free law. A 2008 statewide survey found that 69% of Wisconsinites favor a statewide smoke-free law. As smoking rates decline, so does the customer base of smokers. In communities in Wisconsin that have gone smoke-free, tavern owners have successfully made the transition by implementing common-sense solutions. Here are some tips to help you succeed:

- Develop a plan ahead of time
- Talk to your customers especially your smokers
- Prepare an accommodating outdoor space
- Examine food and snack options
- Train your employees
- Follow the law, and let your customers enjoy themselves


