Introduction

This overview provides information on California's changing demographics, usage and funding of free and community clinics and hospitals, and health plan costs and options. It was developed to help advocates, policymakers, researchers, and others note demographic movements in the state's population, identify both patient utilization and funding trends in its safety net services, and recognize cost changes in its employer-based and private insurance markets.

This Statewide Overview provides a comparison of six regions: Bay Area, Central Coast, Central Valley, North Central, North Rural, and Southern California (a list of counties analyzed in each of these regions is available in the Appendix). For a county and regional perspective, please see ITUP's website at www.itup.org.

This report provides five snapshots of California: a General Perspective, providing an update on California's economic and demographic changes from 2003; a Focus on Community Clinics, examining the utilization and funding mechanisms of California's free and community clinics; a Focus on Hospitals, offering a similar analysis on the usage and financing of California's hospitals; a Focus on County Health Funding, analyzing the economic state of the county health system; and a Look at Employer and Private Insurance plans, presenting a sample of health insurance offerings and premiums for small employer and individual health plans. Select tables outlining data by county and/or comparing ITUP's 2003 regional report information with data offered in this report are available in the Appendix.

Section I: General Perspective

Economy

The statewide unemployment rate is 6.7%. At 5.4%, North Central has the lowest regional unemployment rate. The largely agricultural Central Valley has the highest rate, 12.9%.

Demographics

California's regions experienced moderate growth from 2000 to 2003. The state increased in population by 1.4% from 2002, rising by 4.8% from 2000 to 2003.

Of the state's residents, 14.2% live below the federal poverty level. At 8.7%, the Bay Area has the lowest percentage of residents living in poverty while at 20.5%, the Central Valley has the highest proportion. A third of California's residents (33.1%) live below 200% of FPL while 18.8% live between 100-200% of FPL.

Insurance Coverage

About 21.1% of California's residents do not have insurance. Medi-Cal covers 18.9% of elderly and non-elderly residents. Healthy Families, meanwhile, provides insurance to 2.2% of the region's non-elderly.

Hispanics compose the greatest proportion of Medi-Cal and Healthy Families enrollees at 51.4% and 57.8%, respectively. Whites make up 22.3% of Medi-Cal members and 13.5% of Healthy Families enrollees. Blacks and Asian/Pacific Islanders comprise near equal percentages of Medi-Cal enrollment (10.7% and 10.0%, respectively).

Medi-Cal managed care is in operation in five of six of California's study regions. As expected by it's large population, Southern California comprises the largest proportion of Medi-Cal managed care enrollment.

Local children's coverage expansion programs are in operation in all but two of California's regions with many counties currently in the planning stages of development. Coverage is provided to Medi-Cal or Healthy Families ineligible children regardless of immigration status. Together, these programs cover over 75,000 of the state's children.

Section II: Focus on Community Clinics

Patient Demographics

Seven hundred sixty-eight free and community clinics provided care to 3.3 million patients in 2003. A majority (61.5%) of patients live below the federal poverty level. Table 7 notes the reported race and ethnicity of the state's clinic patients.

Utilization

There were 10.2 million visits to California's free and community clinics in 2003. Uninsured patients make up the largest proportion of visits, 47.0%. In 2003, there were 0.7 visits per uninsured county resident.

Financing

California's clinics received \$1.5 billion in operating revenue; expenses outpaced revenue by \$20.9 million. Patient fees are the greatest source of revenue, providing 62.3% of total funding. Those with Medi-Cal contribute the greatest proportion of revenue received from patient fees (46.2%).

Among uninsured patients, Family PACT captures 35.9% of revenues received from the uninsured, county/CMISP programs 28.0%, and self-payers 19.5%. Other sources, such as funds from the Expanded Access to Primary Care (EAPC) and Child Health Disability Prevention (CHDP) programs round out the remainder of uninsured revenues.

Section III: Focus on Hospitals

Utilization

In fiscal year 2003, California hospitals provided 17.0 million inpatient days, 43.2 million outpatient visits, and 7.5 million emergency department visits. Medicare pays the greatest proportion of inpatient stays, covering 40.1% of days, while private insurance pays for more outpatient visits and ED visits (39.5% and 38.2%, respectively)¹. The county indigent (uninsured) accounts for 3.4% of inpatient days, 5.5% of outpatient visits, and 6.2% of ED visits.

Financing

California hospitals report receiving approximately \$1.5 billion in revenue from the county in FY 2003 (3.6% of net patient revenue). The Office of Statewide Health Planning & Development (OSHPD) states California hospitals reported \$1.8 billion in Gross DSH funds while MICRS/CMSP reports \$1.5 billion Gross DSH payments to the state².

Using MICRS data, total county expenditures on inpatient, outpatient, and emergency department services for the uninsured increased from the previous year, totaling \$1.8 billion compared to \$1.6 billion previously. Inpatient spending edged out all other spending, representing 46.8% of expenses. Outpatient spending per unit of service is \$161.51; inpatient spending per unit of service is \$2,040.86.

California hospitals reported an aggregate loss of \$1.2 billion in bad debt and charity care. This represents a loss of 2.9% of net patient revenue.

Section IV: Focus on County Health

Demographics

The county indigent comprise 5.2% of the region's non-elderly population. California counties provide services to 1.6 million indigent patients, up 3.5% from the previous year.

Funding

California counties received \$2.6 billion in realignment, Prop. 99, county match, Net County DSH, and tobacco settlement funds, an increase from the \$2.3 billion received in the previous year⁵. About 68.8% of total funding was spent on the uninsured, down from 72.3% in 2002⁶. Funding per county resident and per uninsured county resident is noted in Tables III-27 and III-29 located in the Appendix.

Section V: Small Employer & Private Insurance Plans

Approximately 57.7% of individuals have employer-based coverage in California while 6.2% privately purchase a plan.

PacAdvantage

The PacAdvantage purchasing pool, established in 1992, offers access to health coverage for employers with 2 to 50 employees. Through pooling employers statewide, its goal is to increase the affordability of health insurance products for small business owners. Products available through PacAdvantage include medical, dental, vision, and chiropractic options. In California, the range of PacAdvantage HMO plans range from zero in the North Rural area to six in Southern California. At least one PPO and alternate product is available in a given region.

Benefits

Benefits for California's standard HMO products remained stable from the previous year. All standard HMOs continue to have no deductibles and \$30 co-payments for office visits. The price of an inpatient admission similarly remained stable, costing \$1000 for all standard HMO plans. As in the previous year, out-of-pocket costs for prescription drugs are \$15 for generic and \$30 for brand name prescriptions. Premium costs for a sample of PacAdvantage offerings follow:

Small Employer Group Plans

Benefits

Benefits for small employer plans did not change from the previous year for the studied sample of standard HMO products. Co-pays were \$10 for generics and \$20-\$25 for brand name drugs, while office visit co-pays were generally \$15 per visit. Emergency department co-pays range from \$50-\$100 but are waived upon a hospital admission.

Section I: General Perspective
