## Fundraising for Medical Liability Reform Signature-Gathering Campaign Dwarfs Other Signature-Gathering Efforts

In their effort to place limits on medical malpractice awards on the November 2004 ballot, doctors have raised \$1.6 million, nearly 10 times the amount of the next largest signature-gathering PAC.

Contributions to the medical liability reform effort illustrate the continuing domination of signaturegathering fundraising by a few political players. The top four givers donated \$939,710 for initiative petition #85 (medical liability reform)—nearly two-thirds of all of the money raised for that signaturegathering effort. The top 10 donors to all of the PACs gave \$1,315,024, which is 64.7 percent of all of the money raised for signature gathering to date.

By contrast, in 2002, 17 PACs reported raising a total of \$644,264 through the first two disclosure periods to gather signatures for the 2002 November ballot. That's about one-third of the \$2,031,466 that 11 PACs have reported for the parallel period this election cycle.

Contributions of \$200 or less, often considered an indicator of grassroots support, accounted for only 4.2 percent of all giving to signature-gathering PACs for the reporting period.

The ballot language of Medical Liability Reform (petition #85) remains before the Oregon Supreme Court and has not yet been approved for circulation. That has not stopped backers from raising more than \$1.6 million, largely from physicians and other medical interests. Medical businesses, such as Kaiser Permanente and Northwest Physicians Mutual Insurance Company and Neonatal Specialists PC, account for 81.7 percent (or \$1,309,710) of the money raised; 509 individuals gave the virtually of the remaining money (with \$905 coming in the form of miscellaneous cash contributions of \$50 or less). The average donor gave \$2614 to the effort. More than 99.5 percent of the money came from Oregon sources.

Other initiative efforts are not immune from the influence of a few large donors. The Wild Salmon Center, an Oregon-based "international nonprofit organization dedicated to protecting Pacific salmon, steelhead, char and trout stocks and their ecosystems," has put forward 90.4 percent of the funding for the Tillamook 50-50 Plan (petition #65). They list 28 foundations and reference individual donors on their website.

Five donors gave 81.5 percent of the money to the Measure Requiring Compensation for Regulations Taking Value of Property. They include ADEC, Inc., Seneca Jones Timber Co., Freres Lumber Co., Inc., Columbia Helicopter/Wes Lematta and Oregonians in Action.

Kristina Wilfore, who follows initiative trends as executive director for the non-partisan, Washington, DC-based Ballot Initiative Strategy Center and Foundation, has seen increased interest in limiting medical malpractice awards at the ballot box. Texas passed a measure in 2003 to limit damage awards. A measure that would further restrict medical malpractice suits in Nevada has qualified for 2004. Similar efforts have been launched in Arizona and Florida.

"The proposals differ— but the essence of each of them is to shift the blame for the rising cost of medical care from insurance companies to trial lawyers and consumers with frivolous lawsuits," said Wilfore.

Signature-gathering PACs must submit periodic disclosure reports if they raise or spend more than \$2000 in a period. Only 11 PACs have reached the mandated threshold. (The Secretary of State's office has qualified five additional petitions for circulation, but those PACs have not reached the \$2000 threshold.)
