Medical Malpractice Reformers Poised to Break Fundraising Records **Other Ballot Measure Campaigns Dominated by Small Numbers of Large Donors**

Two PACs have raised more than \$5 million to pass measure 35, which would limit non-economic damages in medical malpractice cases, threatening to break the record amount of money raised for either side of a ballot measure fight since 1986.

The record, raised in a successful effort to stop a 1992 ballot measure to shut down the Trojan nuclear power plant, neared \$6.5 million in inflation-adjusted dollars. Two more disclosure periods remain in this election to determine whether the campaign will break the record. The "yes on 35" fundraising figures include dollars carried forward from that effort's signature gathering PAC, which raised far more money than was required to qualify for a spot on the November ballot.

Of the remaining five measures, four of the "no" sides are winning the fundraising race. The last measure, which would change Oregon's medical marijuana laws, is not facing an opposition political committee.

The fundraising underdogs in half of the measure matchups are struggling to keep up, having raised between 50 and 75 percent of their opponents' money. Having raised only 3.8 percent of "no" side's money, proponents of measure 34, which would change how some state forests are managed, have been drowned out by the measure's opponents. The fight over

medical malpractice reform is lopsided, with the "no" side raising only about one dollar for every three the "yes" side raised. The medical marijuana campaign is not facing an opposition PAC. (See Chart 2 for details.)

Most of the campaigns on both sides of the measures rely on a few contributors for their cash. With the exception of the "yes" side of Measure 36, the top 10 contributors make up more than 60 percent of contributions to each of campaign efforts and contributors giving \$50 or less make up less than 10 percent of contributions.

Liberty Northwest continues to be the overwhelming driving force behind measure 38, which would abolish rival insurance provider SAIF, contributing all but less than one-tenth of 1 percent of the money raised to pass the measure. On the "yes" side of the Medical Marijuana campaign, the Marijuana Policy Project contributed 97 percent of all of the money the campaign raised.

Timber interests are top donors to three ballot measure campaigns, primarily focusing on defeating ballot measure 34, which would change management of two state forests. Several timber companies are also top donors to the "yes on 37" effort to require government payments to property owners facing land use regulations. Two lumber companies are major donors to the committee to defeat measure 38. Construction industry groups, which like the timber industry face serious workers' compensation insurance concerns given the potential for injuries in their industry, are also major "no on 38" donors.

Union contributions are significantly smaller this election cycle since there are no measures targeting labor. Unions, however, are major supporters to the "no on 37" committee, presumably because of the impact that measure could have on local governments and government workers.

"Who gives to ballot measures often reveals important clues about what is at stake in the campaign. In the absence of party affiliations and other ideological cues, disclosure reports provide crucial information about why voters are being asked to vote either way on what may be ballot measure with a narrow base of support," said Sarah Wetherson, research and outreach associate with the Money in Politics Research Action Project.
